Framework for people with Learning disabilities

The adult disability service had a review in 2019.

The people who use the service were asked about “How I spend my time”.

Changes are now being made to the day service.

Different groups will be made to focus on therapy, learning and occupation and employment.

Three local student nurses have finished the first year of a training course in disability nursing.



Discrimination Law

A draft of the law has been written. A consultation has taken place. This means people can review the draft and make comments on it.

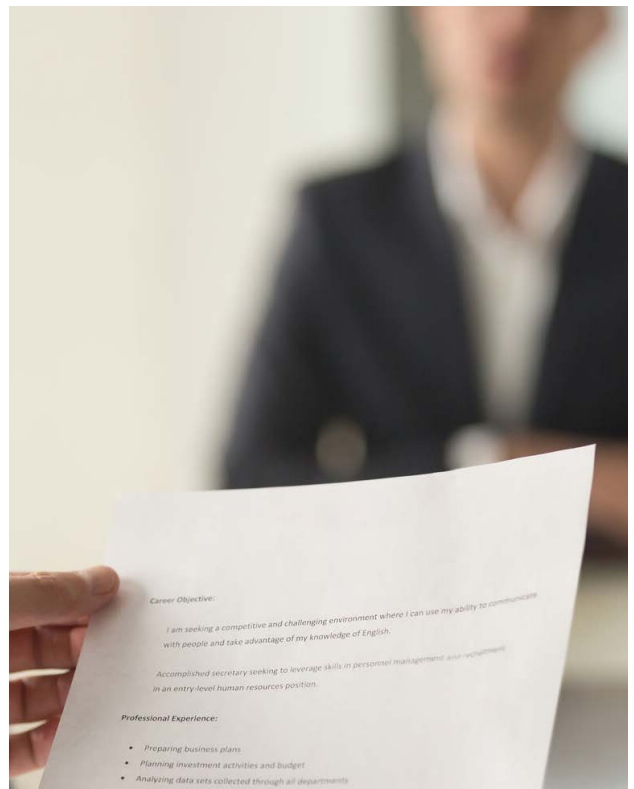
Changes will then be made before it goes back to the States later this year.

Two social media videos were made.

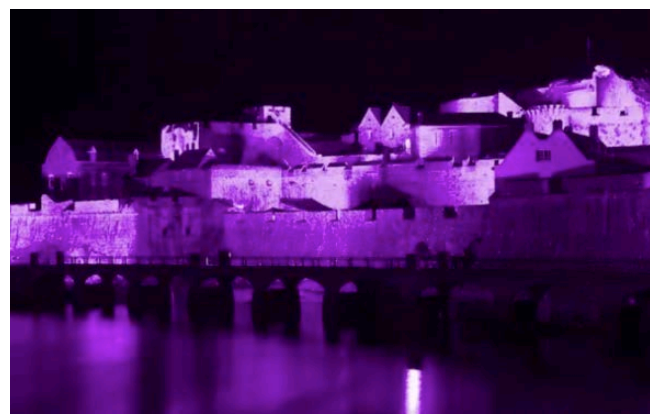
One showed the new paths at the millennium walk which will make it easier for everyone to visit.
